Position Overview

- Responsibility for maintaining a clean and sanitary production facility
- Specializes in cleaning and sanitizing equipment, floors, walls and other surfaces in a cGMP facility

Responsibilities & Duties

- Ensures that all manufacturing equipment are cleaned, sanitized and handled according to company standards
- Assists in the cleaning of production lines and ensures that lines are properly cleaned within the acceptable timeframe
- Cleans facility areas following the Mater Sanitation Schedule
- Properly handles and uses chemicals for sanitation and uses only approved chemicals for the approved purpose
- Operate pressure washers, scrubbers and other janitorial type equipment
- Move and dismantle equipment to ensure proper cleaning and sanitization
- Use both wet and dry mops to perform necessary duties
- Regularly check the trash receptacles on the sales floor and empty as necessary
- Empty waste containers and remove scrap, dirty and heavy debris or other refuse
- Dusting interior frames, racks, shelves and ledges
- Follow all procedures and wear personal protective equipment as outlined in the health and safety manual
- Assists in tour and audit preparations as required
- Performs other duties as assigned

Education & Experience

- Post-secondary education in an applicable field required.
- Strong English communication skills (written and verbal).
- Ability to work and multi-task in a fast-paced environment and meet strict deadlines.
- Proficient in maintaining organized and accurate records and logs
- Demonstrated ability to work independently with little supervision

- Ability to wear latex gloves required
- Works in a manufacturing environment with regular exposure to chemicals, dust, grease, oil, noise or temperature extremes
- Occasionally faces multiple demands or distractions
- Regular exposure to machinery or equipment
- Standing for extended periods of time at a computer station or work desk; stands and walks regularly throughout the day; uses hands and fingers to operate computers and production equipment for up to 8 hours each day;
- Repetitive bending, twisting, crouching
- Repetitive manual movements
- Occasional reaching, climbing, lifting
- Position does not require travel
